The Committee reviewed progress on 'open' actions agreed at previous meetings.

#### 367/23 PUBLIC PARTICIPATION

The Group Co-ordinator of Wallingford Community Speedwatch attended and addressed the Committee on the public consultation being run by Oxfordshire County Council on a proposal to increase 20 mph speed limits within the town. She explained her concerns that the proposals had omitted several roads, did not extend to the bypass, contained proposals to maintain a 30 mph limit in some areas near schools, and that public knowledge of the consultation appeared dependent on social media posts by individual councillors or press coverage.

Alterations to existing retail unit, demolition of existing single-storey buildings and concrete deck to the rear. Creation of an open courtyard with alterations to existing rear buildings to form 3 residential units and the construction of 1 new residential unit.

# (c) Longcross Place, 18 Winterbrook, Wallingford, OX10 9EF P23/S3392/S73

Variation of conditions 2 (Approved plans), 3 (Levels), 4 (Schedule of Materials), 6 (Retention of existing boundary walls), 11 (Biodiversity Enhancement Plan), 12 (SWD Implementation), 16 (Construction Traffic Management), 17 (Cycle Parking), 20 (Electric Vehicle Charging Points), 21 (Construction Method Statement), 22 (Implementation of Programme or Archaeological Work) and 23 (Archaeology (Submission and implementation of WSI) on planning application P21/S1415/FUL to amend the list of approved plans to capture proposed changes to the external appearance and internal layout of the building. The erection of 23 retirement apartments (age restricted to 55+) including associated communal facilities, parking, access, and landscaping, following the demolition of the existing 35-bedroom nursing home and all associated outbuildings.

# (d) Wallingford Portcullis Social Club, 28 & 29 Goldsmiths Lane, Wallingford, OX10 0DU

P23/S3487/S73

Variation of condition 2 (approved plans) on planning application P18/S0003/FUL - to amend the north side of House 7 (now known as Plot 8) roof from a hipped to gable end design Demolition, part demolition,

redevelopment and change of use of the Portcullis Club building and No29 to provide 14 residential units. Eight two-bedroom houses, three two-bedroom flats and three one-bedroom flats.

P22/S2675/FUL (Dwelling house and associated works) - 2 (approved plan) - addition of window to porch; 12 (energy statement compliance) - updated report; 3, 4, 5, 7, 8, 9, 10, 11 & 13 - to be renumbered, 6 - renumbered & reworded as works have already commenced under condition 1.

#### 367/23 OXFORDSHIRE COUNTY COUNCIL (OCC) CONSULTATION

The Committee NOTED that Oxfordshire County Council (OCC) had initiated a the public consultation on the increase of 20 mph speed limits in the town, following the request made by the Full Council on 25 September 2023. However they were surprised at the apparent low level of promotion, that the proposals included 30 mph limits in some school areas, that the proposals omitted some roads and do not extend to the bypass.

#### Action:

Meetings Officer to contact County Councillor Sudbury to talk through these concerns, to arrange additional promotion by the Town Council of the public consultation and to discuss with the Mayor whether there is value in the Full Council discussing the substance of OCC's proposals at their next meeting on 20 November 2023 with the aim of delivering a collective response, asking for a slight extension to the consultation which is currently scheduled to complete on 17 November 2023.
