Upgrade existing boundary fencing with weldmesh powder coated metal fence panels - between 1m, 2m & 2.4m high in black and blue. New automated 2.4m high powder coated metal vehicular gates including Paxton access controls, plus two manual 2.4m high powder coated metal pedestrian gates either side all off Trenchard Close. New manual set of pedestrian gates and black hoop top railings to match existing to pedestrian entrance off St John's Road, plus access controls.
